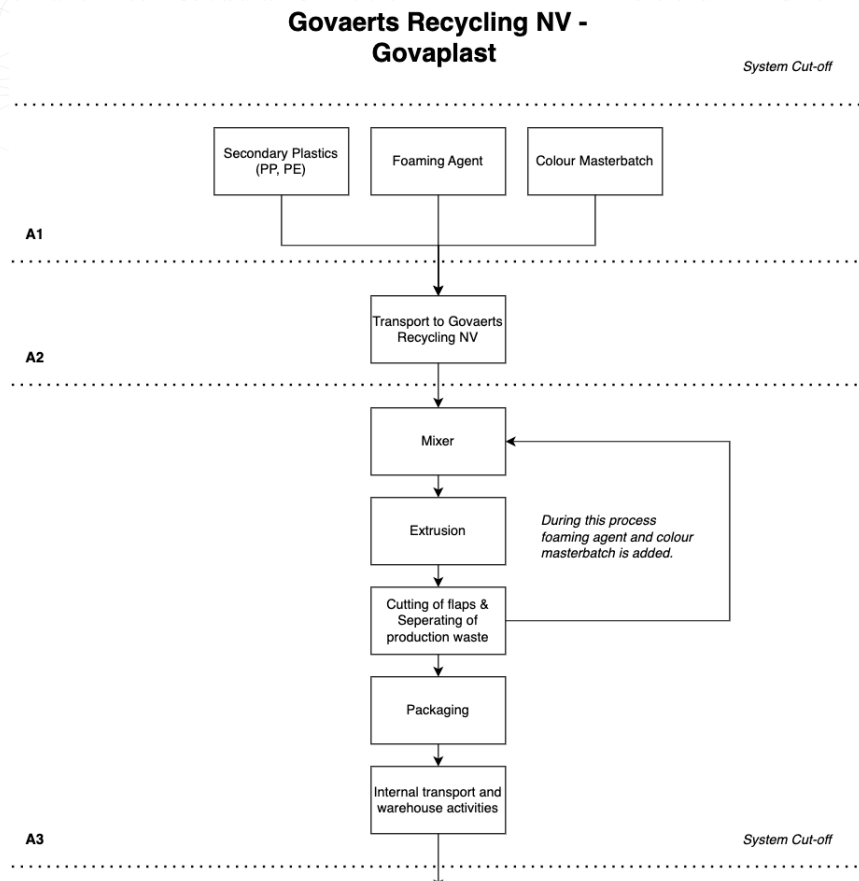

General Product Information

Govaplast semi-finished products are mainly produced from secondary plastics (PE, PP) which are purchased from various plastic suppliers and recyclers. In addition, additives are added to obtain the correct color. The Govaplast plastic semi-finished products can be developed in the form of beams, poles, planks or plates. Govaplast semi-finished products are produced in various colorways. This document refers to the **mineral grey** colorway.

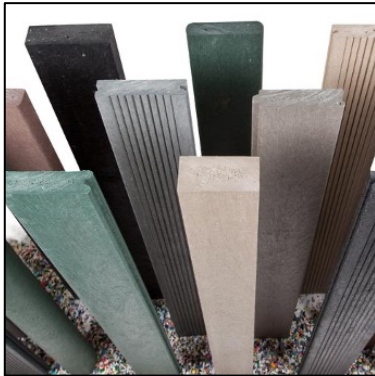


Figure: Representation of Govaplast semi-finished products.
